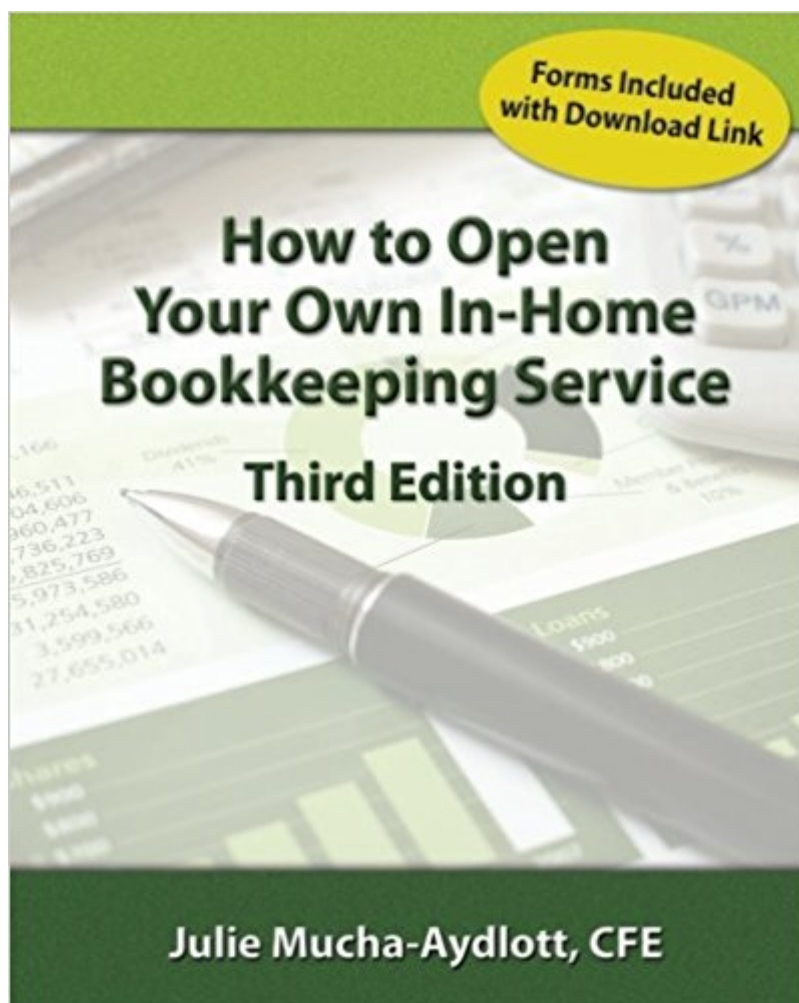

I bought my first copy a few years before I actually started my business, then when I got serious, and this book by Julie was my guide. I've read LOTS of bookkeeping books which all have provided insight but this one gives you the WHOLE picture. You won't be disappointed.

This book is very easy to read, very informative and provides a lot of great resources. The forms she offers with the book are great tools to get the documents you need started. Just in the first 4 chapters I read, I had learned so much more information than what I found researching the Internet. I recommend this book to anyone trying to get their own bookkeeping business started. Two thumbs up.

I'm already a member of AIPB and making full use of their resources, but this book filled in a lot of gaps for me about the daily challenges faced by a freelancer and how to meet them. I was also happily surprised that the customizable forms worked on my Mac. I went to the URL mentioned in the book and downloaded my forms at no extra charge. To clarify: I have automatic Mac OS updates, so I always have the latest version. Not only were the Word docs and Excel forms automatically converted to Pages and Numbers files, but I have been rapidly customizing them for my own use. I can't say enough good things about this book.

This book arrived on time in perfect condition and will be used in the future to guide me with starting a home-based business. I checked an early edition of this book out at the local library and figured I would just purchase an edition for myself. Very useful book and very easy to read.

I was disappointed that the kindle boom didn't come with anything to reference the information on the CD (business plan) that the book does. The price should be a bit lower. The book was still well written and a great resource itself.
